Terms & Conditions:

1. Tender documents can be collect from IDEA/YOUTH Organization office, H. No 29-B, Chaman Housing Scheme, Airport Road, Quetta, from 9:00am to 5:00pm, Monday to Friday. The tender pack can also be downloaded from our website <http://www.idea.org.pk/ads.php>
2. Sealed tenders should reach IDEA/YOUTH Organization office, H. No 29-B, Chaman Housing Scheme, Airport Road, Quetta on or before 02:00pm 26-10-2022 and should be clearly marked "TENDER for Lot No. ____ - Not to be opened before 02:30am 26-10-2022".
3. Tenders will be opened on the same day i.e. 26-10-2022 at 02:30pm in the presence of suppliers or their representatives, who wish to witness the tender opening.
4. In case a public holiday is announced by the Government (Due to any reason) the tender will be opened the next working day at the same time and venue.
5. Supplier must quote only one option for each item. Bids received with more than one options, and rates may be rejected.
6. Suppliers must quote price of all the items in a lot. Partial quotation of any lot will be rejected.
7. Rates for supplies must be inclusive of all type of taxes, packing, and all other allied costs
8. Delivery charges upto the delivery point including loading/unloading for each lot, should be mentioned separately.
9. Supplier must submit the samples along with their bids for lot No. 1, 2 and 3. Bids without samples may be rejected.
10. Bidder are required to submit bid Security @ 2.5% of the bid value (for Lot 1, 2 and 3 separately) in the form of CDR/Pay-order in favour of "IDEA". Bids without bid security may be rejected.
11. Bidders can apply for a single or multiple Lots. IDEA reserves the right to divide the order Lot wise.
12. Tender committee reserves the right to change the quantities or cancel/reject any or all offers without assigning any reason.
13. Suppliers must not be engaged in any corrupt, fraudulent, collusive or coercive practices including but not limited to applying/ bidding by multiple names / companies. If any bidder is found to be involved in such practices his/her bid may be rejected and the companies in question permanently black listed
