Terms & Conditions:

1. Tender documents can be collected from House # 2, Street # 1 Rahatabad Peshawar from 9:00am to 5:00 pm, Monday to Friday, till April 30, 2023. The tender pack can also be downloaded from our website <http://www.idea.org.pk/ads.php>
2. Sealed bids along with samples as per the instructions in the ITB (Invitation to Bid), must be submitted on or before May 01, 2023 before 11:00AM at House # 2, Street # 1 Rahatabad Peshawar Bids received without samples may be rejected.
3. Bids must be submitted in sealed envelopes, marked “TENDER – Tool Kits for skill training (Lot No.)”
4. In case a public holiday is announced by the Government (Due to any reason), the tender will be opened on the next working day at the same time and venue. Or will be informed to suppliers for opening session.
5. The Supplier must quote only one option. Bids received with more than one options and rates may be rejected.
6. Bidders must quote all the items mentioned in a Lot. Partial or incomplete quotations will be rejected.
7. Cost must be given in Pak Rupees including all applicable government taxes. (WHT & GST)
8. Cost must be inclusive of taxes, delivery charges, packing, loading/unloading and all other allied costs.
9. Taxes will be deducted at the time of payment as per the Government regulations
10. Payment details of the supplier must be clear stated e.g. to whom cheque should be addresses and if necessary.
11. Supplier/vendor/company will have to submit a pay order/ demand draft in favour of “IDEA” with a value of 5% of the bid amount as a bid security.
12. Bidder may apply for a single or multiple lots. Tender committee has right to divide the order lot wise.
13. Tender committee reserves the right to change the quantities or cancel/reject any or all offers without assigning any reason.
14. Suppliers must not be engaged in any corrupt, fraudulent, collusive or coercive practices including but not limited to applying/ bidding by multiple names / companies. If any bidder is found to be involved in such practices his/her bid may be rejected and the companies in question permanently black listed
15. Lowest price will not be the sole criteria; quality material, delivery time and previous experience will also be considered.
